- All visitors, guests and spectators must check- in & provide photo ID. (More information can be found under "Safety" heading).
- The following are behaviors considered inappropriate in our center and programs, and therefore are NOT ALLOWED VERBALLY ABUSIVE or offensive behavior-including angry or vulgar language, swearing name-calling or shouting
- HARASSMENT or intimidation by words, gestures, body language, or any type of menacing behavior
- PHYSICAL CONTACT with another person in an angry, aggressive, or threatening way
- INTENTIONALLY PHOTOGRAPHING children other than your own; no cell phone/camera use in any restrooms or changing rooms
- SMOKING, VAPING, or any inhaled or edible forms of MARIJUANA
- Using or possessing ILLEGAL CHEMICALS (drugs), or alcohol, on TSA property, in vehicles, or in sponsored programs
- Any INJURY must be reported prior to leaving the facility
- Carrying a concealed WEAPON or any device or object that may be used as a weapon or to harm another person are not allowed on property unless carried by qualified active and/or retired law enforcement
- INAPPROPRIATE, immodest, or revealing ATTIRE
- Sexually EXPLICIT conversation and behavior or engaging in inappropriate contact with another
- THEFT or behavior that results in the loss or DESTRUCTION of property. TSA is not responsible for lost or stolen items while utilizing TSA facilities/programs
- LOITERING on TSA property
- ANIMALS are not permitted in the facility or on TSA property (ADA service animals are exempt)
